1. Introduction:

The Andhra Pradesh State Co-operative Bank (APCOB) invites sealed bids from eligible and experienced interior design and execution firms to undertake a project aimed at transforming our head office's interiors. This project involves designing, preparing, and labor for the installation of customized wall frames that will artistically depict APCOB's remarkable journey from its inception in 1963 to the present day. A total of 48 frames are to be strategically placed in the four staircases of our five-story building i.e., 12 frames per floor, total= 4x12=48 frames.

2. Project Scope:

The scope of this project includes, but is not limited to:

- Designing customized wall frames that illustrate key milestones and achievements in APCOB's history.
- Preparing high-quality prints or artworks to be placed within the frames.
- Labour and installation work, ensuring the frames are securely and aesthetically placed in the designated staircases.
- Compliance with safety and quality standards.

3. Eligibility Criteria:

Interested vendors must meet the following eligibility criteria:

- Proven experience in interior design and execution projects, particularly in corporate or institutional settings.
- Demonstrate the capability to create customized artworks that reflect the historical journey of organizations.

- Possess adequate resources, including skilled personnel and equipment, to complete the project within the stipulated time frame.

Relevant experience and portfolio of similar projects (10%)

Proposed design concept and creativity (30%)

Financial proposal (60%)

The contract will be awarded to the bidder with the highest score based on the evaluation criteria. APCOB reserves the right to accept or reject any or all bids without providing any reasons.

8. Terms and Conditions:

All bidders must adhere to the following terms and conditions:

- The bidder shall provide a detailed project timeline of not more than 1 month and adhere to it.
- The bidder shall be responsible for any damage or delays caused during the execution of the project.
