1.	Educational /Professional Qualifications	Graduate/Post Graduate in Law and should be enrolled/registered as an Advocate on the rolls of State Bar Council of Andhra Pradesh.
2.	Place of Practice/Office	Within the area of operation of APCOB i.e., Vijayawada or Guntur.
3.	Specialization	Civil, Criminal, Insurance, Corporate, Contract Laws, Taxation Laws, Co-operative laws, Banking and Finance Laws, Intellectual Property Law and Data Protection Law.
4.	Experience	minimum of 05 years' active practice as an advocate. (or) minimum of 05 years' experience of having worked as a law officer in a Government Department or agency, a Bank or other FIs.  <i>* In case of a law firm being the applicant, then the senior most advocate of the firm should have the said qualification.</i>
5.	Expertise	Should have expertise in diversified areas of Law including APCS Act, 1964 and Co-operative laws, recovery litigation before DRTs, Cooperative Tribunals, District Courts, Court of Deputy Registrars and also SARFAESI Act, Consumer Forum cases.
