- 2. The average annual financial turnover during the last 3 financial years (ending March 31, 2024) must not be less than INR 30 Lakhs.
- 3. The bidder must have a valid PAN number, GST Registration number, TIN, and CIN registered in the State of Andhra Pradesh.
- 4. The bidder must submit a Manufacturing Authorization Form (MAF).
- The bidder must submit an Earnest Money Deposit (EMD) of Rs. 20,000 (Rupees Twenty Thousand Only) in the form of a Demand Draft drawn in favour of APCOB along with the bid.



Terms and Conditions:

- Model/Product/Part Numbers should be mentioned for all items.
- The tax component should be mentioned separately as applicable.
- Delivery of products should be within 1 week from the date of the Purchase Order.
- Payment will be made only after the successful delivery and Completion of Installation process of the product at the Bank's premises.
- Delivery Challan and Installation Reports must be submitted along with the products upon delivery
- Any repair/damage to the supplied hardware within the warranty period must be attended by the vendor.
- The Bank reserves the right to modify/amend/cancel the tender process or procurement without assigning any reason at any time.
- The warranty period for all hardware is 3 years, and support should be provided whenever the Bank raises a request.
- No additional charges will be paid outside the quoted price

Submission of Bids

Technical Bid:

- 1. Submit in a sealed envelope marked "Technical Bid".
- 2. Include compliance with specifications, signed eligibility documents, and no pricing information.

Commercial Bid:

- 1. Submit in a separate sealed envelope marked "Commercial Bid".
- 2. Include price details and total cost.

Note:

1. Technical and Commercial Bids must be in separate envelopes.

2. Only technically qualified bids will move to the Commercial Bid opening.
