#### **TERMS & CONDITIONS**

- 1. The Annual Maintenance Contract will be a period of one year. Bank, at its discretion may extend the term further for a period of one year.
- 2. Only authorized and approved components (smell less) will be permitted to be used for pest control during the AMC Period. Any one of the following chemicals are to be included:-
  - (a) Imidacloprid 30.5% (or)
  - (b) Fipronil 2.92% (or)
  - (c) Chloropyriphos 20%
- 3. It is the responsibility of the Vendor to maintain all our premises termite free.
- 4. All the category items (mentioned for AMC) covered in this contract have to be maintained as per the standards approved and authorized.
- 5. Pest Controlling to be carryout minimum once in a quarter for each our premises. Further, the same may be repeated in the same quarter, if required.
- 6. Payment Terms: AMC Charges will be paid at end of every quarter year of the AMC period after submission of bills along with service reports. Bills will be cleared only when the complete list of Branches allocated to the vendor is submitted duly signed/ endorsed by the Branch along with the copy of service report.
- 7. The Bank is at liberty to make additions/deletions/ modifications/ amendments in the tender document and the applicants are bound by the same. Reasonable extension of time will, however be given to them to revise their Price Bids in case such additions/deletions/ modifications/ amendments are material in nature.
- 8. If any, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the AMC of such applicant will be cancelled immediately.
- 9. Firms should have registration number for payment of GST (Attested copy of proof to be submitted with company seal).
- 10. Tenders which are not in sealed covers will not be accepted.
- 11. Proper Identity cards (with photograph) are to be issued to the service persons to have access to the location / sites and the said personnel should report to the concerned Security Officer / bank official while attending to the maintenance/service.
- 12. No payment of any nature is to be obtained from the staff at the location. Payment of AMC shall be done from controlling office on production of service reports & invoice only.

- 13. Any abnormally low rates quoted with regard to the prevailing market rates may entail disqualification from participating in the tender process and may be summarily rejected by the bank.
- 14. The bank reserves the right to terminate the service contract with one month notice without assigning any reason whatsoever.
