The L1 firm must offer one Year warranty on all items including accessories. No charges will be paid to the firm for service/repairs/replacement of defective items during the Warranty period. Service support during the Warranty/ AMC period must be provided ON-SITE as and when required.

Further, the firm must provide service through Annual Maintenance Contract for a minimum period of 4 Years on completion of warranty period.

6. Evaluation Criteria:

Bidder must quote the total amount including all taxes including transportation & installation of items as per the Scope of Work mentioned above. No extra cost will be paid for other than quoted amount. Bidders who quoted the least amount will be awarded the contract.

7. Terms and Conditions:

- a) The Bid participant must visit APCOB Head Office to assess the Scope of Work and for checking feasibility prior submitting quotation.
- b) Rates quoted must be inclusive of Taxes and other charges as applicable.
- c) Total work to be completed within 30 days from the date of acceptance of Work order beyond which penalty will be charged at the discretion of Bank.
- d) No Advance payment will be made. Payment will be disbursed on submission of bills after completion of the works as per the Scope of Work mentioned above.
- e) Contract will be cancelled if the items are not of good quality and standard. Bank reserves all rights to modify or cancel the bid.
